Statement of the Student Union on the extent of doctoral degrees

The university has requested a statement from the Student Union on the extent of doctoral degrees. The deadline for the statement is Monday 15 Jan 2024.

The call for comments is intended to review the view of the university community on the need for changes and the extent of doctoral degrees in the future. Comments are requested as widely as possible from different parties. The results will be presented to the Board of UTUGS. The Board includes Vice-Deans for doctoral education of the faculties and representatives of doctoral researchers. After this, a summary of statements, views of the faculties and the proposal of the Board of UTUGS for a Rector's decision will be submitted to the Rector.

Those providing statements are requested to comment, in particular, the following proposals:

• The extent of the post-graduate studies in a doctoral degree in all faculties from 1 Aug 2024 will be 40 ECTS.

• The doctoral dissertation is no longer measured in ECTS.

• Another change is made to the extent of post-graduate studies (the response should include the proposed change).

Secretary General proposes:

The Executive Board decides to comment the extent of doctoral degrees.

Appointing a representative in the premises working groups of the lower campus

As part of the premises programme required by the Board, the Rector appoints to working groups to discuss the premises arrangements of the lower campus. The task of the first working group is to discuss the possibilities to locate the teacher training school in the campus and the other working group discusses the premises arrangements of the lower campus if the teacher training school or part thereof is moved from Varissuo to the lower campus.

The university has asked TYY to appoint representatives in both working groups.

Secretary General proposes:

The Executive Board decides to appoint a representative and a possible deputy representative in each working group.

Appointing a representative of the Student Union in the Management Group of the University

The Management Group of the University includes Rectors, directors in the central management, Deans, Director of UTUGS and a representative of the Student Union. In the Management Group, the Student Union has been represented by the Chair of the Executive Board. The University Management Group has been previously called the extended management board.

The Specialist for Academic Affairs proposes:

The Executive Board decides to grant Akseli Tiitta a resignation from the Management Group and to appoint Katie Astin, Chair of the Executive Board, as the representative of the Student Union in the Management Group of the university.

Appointing representatives of the Student Union in the Teaching and Learning Council and its division at the university

The Teaching and Learning Council of the university prepares matters related to education for decision-making by the Board or Rector. In the Teaching and Learning Council, the Student Union has one regular representative and their deputy representative. The term of the Teaching and Learning Council and its divisions is the term of the Rectors.

The regular representatives in the Council have been the Specialist for Academic Affairs and the Executive Board Member for Academic Affairs.

The well-being division is a working group operating under the Teaching and Learning Council and focusing on students' well-being. TYY Specialist for Social Affairs has served as the Chair of the division for several terms. In addition, the division has had another TYY-appointed representative as a member.

The division for developing international degree programmes is a division under the Teaching and Learning Council with tasked with the long-term development and follow-up of international degree programmes. The division started in autumn 2019 and its composition includes representatives from all faculties and the Student Union. A regular member in the division has been the TYY Specialist for International Affairs and an Executive Board member as a vice-member.

The Specialist for Academic Affairs proposes:

The Executive Board decides the representatives of the Student Union in the Teaching and Learning Council and its divisions as follows:

- to grant resignations to Julia Siimento, Kerttu Hurvi and Arvi Tolvanen and to elect a representative of the Student Union in the Teaching and Learning Council and their deputy member. Specialist for Academic Affairs, Joni Kajander, continues as the regular member of the Teaching and Learning Council.

- to grant Jimi Salonen a resignation from the well-being division and to elect a representative of the Student Union as a regular member of the division. Specialist for Social Affairs, Ville Ritola, continues as the Chair of the section.

- to grant Katie Astin a resignation from the division for developing international degree programmes and to elect a representative of the Student Union as a deputy member in the division. Specialist for International Affairs, Satu Nurmi, continues as the regular member.

TYY representative in the digital steering group of the university

The University Board decided on 15 Jan 2021 that steering groups for key activities of the university are established to steer and follow-up the services of the university administration. For education, research and societal interaction, the steering groups consist of councils led by the Vice-Rectors. The Student Union has representation in the Teaching and Learning Council and in the Council for Societal Interaction. In the steering groups for the services of administration, the Student Union has representation in the digital steering group.

The steering groups for the services of administration convene four times a year. The task of the steering groups consists of consultation, preparation and discussion. The steering groups do not make decisions.

TYY representatives in the steering group for general management have been Specialist for Academic Affairs Joni Kajander (regular member) and Specialist for Organisations and Administration Lauri Lahoniitty (deputy member). TYY representatives in the digital steering group have been in 2022-2023 Executive Board Member Arvi Tolvanen (regular member) and Specialist for Academic Affairs Joni Kajander (deputy member).

The Specialist for Academic Affairs proposes:

The Executive Board decides to grant Arvi Tolvanen a resignation and to elect TYY representative as a regular member in the university digital steering group. Specialist for Academic Affairs continues as a deputy member of the steering group.

Appointing a representative of the Student Union in the quality system steering group of the university

The quality system steering group of the university is responsible for developing the quality system of the university. The quality system of the university was audited externally in 2023. The regular member of the steering group has been the Specialist for Academic Affairs and the Executive Board Member for Academic Affairs has been the deputy member.

After the audit year, it is a good time to think about the arrangement of regular and deputy members in the steering group. The Executive Board Member may well serve as a regular member in the steering group and the Specialist for Academic Affairs can become a deputy member.

The Specialist for Academic Affairs proposes:

The Executive Board decides to grant Julia Silmento a resignation and to appoint the representatives of the Student Union in the quality system steering group.

Appointing Student Union representatives in the university teams under Educational Affairs.

There are different teams for internal development of Educational Affairs, which is responsible for services related to education. The teams discuss the practices and processes in the study administration related to their theme area. Educational Affairs has wished for representation from the Student Union in some of the teams. Such teams include student feedback team and curriculum team.

Educational Affairs is led by the steering group of study administration, in which the representative of the Student Union is the Specialist for Academic Affairs. In addition, the Specialist for Academic Affairs is a representative of the Student Union in the teams for internal instructions under Educational Affairs.

The Specialist for Academic Affairs proposes:

The Executive Board decides to appoint the representatives of the Student Union in the teams under Educational Affairs as follows:

- to grant Julia Silmento a resignation and to elect a representative of the Student Union in the student feedback team under Educational Affairs of the university.

- to grant Julia Siimento a resignation and to elect a representative of the Student Union in the internship team under Educational Affairs of the university.

- to grant Kerttu Hurvi a resignation and to elect a representative of the Student Union in the curriculum team under Educational Affairs of the university.
