#### Legality and quorum

Invitation to a meeting of the Student Union Council shall be delivered electronically for all members of the Student Union Council, and the meeting shall be announced at the official bulletin board of the Student Union at least seven (7) days before the meeting.

The Student Union Council constitutes a quorum when at least twenty-one (21) members and the Chair or the Vice-Chair are present. (TYY Rules Section 12)

The matters on the agenda of a meeting shall be informed in the invitation to the meeting. A matter not mentioned in the invitation to the meeting shall not be decided unless declared urgent with a two thirds (2/3) majority or unless the matter needs to be decided, according to the Rules, by a certain date and a new meeting can no longer be invited to decide the matter.

Upon invitation to the meeting, the agenda shall also be delivered to the deputy members of the Student Union Council. (TYY Administrative Rules Section 1)

#### Travel allowances for the meetings of the Student Union and its sub-committees

According to Section 11(2) paragraph 16 of the Rules of the Student Union, it is the task of the Student Union Council to decide on the travel allowances to the meetings of the Student Union Council and its suborgans.

During the term 2022–2023, the travel allowances were paid as follows: "Travel expenses to the members and deputy members of the Student Union and the organs elected by it will be calculated primarily as the cost of the most affordable public transport or the use of one's own car, and secondarily, under discretion of the Secretary General, as other realised costs to the Student Union Council meetings, evening classes and other official events of the organs elected by the Student Union Council in Finland from the permanent place of study or, if required by studies, from another city to Turku. The decision will be applied retrospectively to the training events, evening classes and meetings of the Student Union Council."
