

148 Student Union statement on the draft of the entrance exam entity

Appendix 1 Statement of the Student Union of the University of Turku on the draft of the entrance exam entity (visible in the meeting)

The development project for university student admission aims to make student admission clearer, more functional and less burdensome both for the university and the applicants. For entrance exams, the objective is to develop the entrance exams research-based so that in the future, one could apply with the same exam to more application targets and even several disciplines. According to the draft on the entrance exam entity, in the future, nine national entrance exam combining different disciplines would be organised.

The development project on the entrance exams of universities has requested comments on the draft of the entrance exam entity through the statement service by 25 Apr 2024. The university has requested comments for the draft from faculties, joint application systems and TYY by 23 Apr 2024 in accordance with the division of the projects' call for comments. On the basis of the comments, the project will make the necessary adjustments before the proposal on the entrance exam entity is provided for the universities to decide in May-June 2024.

The project has organised webinars related to the draft on 27 Oct 2022, 29 Sep 2023 and 21 Mar 2024. The university has organised webinars related to the draft on 2 Feb 2024 and 4 Apr 2024. The draft is also sent for comments on the university Vilma platform.

TYY considers that the entrance exam entity and the planned schedule of the entrance exams are primarily to be supported as they clarify the application process and reduce the applicant's possible costs related to applying to university. However, the organisation of the entrance exams should pay attention to the accessibility of the exam situations and the ability of the exams to measure applicability in the applied field.

The Specialist for Academic Affairs proposes

The Executive Board decides to comment the draft on the entrance exam entity both for the University of Turku and the Development project on developing the student admission of universities in accordance with the appendix. The Executive Board authorises the



Specialist for academic affairs to take the statement to the form in the statement service.

Appointing a representative of the Student Union in the steering group of ART project

Rekry - Career Services of the University of Turku has launched an ESRfunded project called "ART - Academically tailored trainee programmes" and requests TYY to appoint a representative in the steering group of the project. The aim of the project is to promote the employment of university students in companies in the region by creating a university-led trainee programme concept. The concept combines on-the-job-learning and further education as well as the mutual networking of the trainee students and supporting them becoming experts. The steering group convenes as planned ca. twice a year. The project period is from 1 Feb 2024 to 31 Jul 2027.
